PUBLIC NOTICE OF EMERGENCY RULES CONTINUING STATE-FUNDED MEDICAL ASSISTANCE FOR CERTAIN NON-CITIZENS

Pursuant to section 91-4, Hawaii Revised Statutes (HRS), the Department of Human Services (DHS), Med-QUEST Division, gives notice that it has implemented emergency rules that temporarily continue State-funded medical assistance benefits to certain lawfully present non-pregnant adult non-citizens who are ineligible for federal Medicaid due to their immigration status, including citizens of island nations with a Compact of Free Association with the United States.

These individuals, referred to as "current beneficiaries," were receiving State medical assistance benefits that are identical to federal Medicaid benefits because of a court order issued in 2010 by the United States District Court for the District of Hawaii. The court order was vacated on November 3, 2014 and the department is therefore required, under its current administrative rules, to reduce the State medical assistance benefits provided to individuals who were enrolled in Basic Health Hawaii before the court order was issued, and to terminate benefits for individuals who began receiving them after the court order was issued.

Therefore, pursuant to the authority of section 91-3(b) HRS, the DHS has determined emergency rules are necessary to avoid imminent peril to the safety of certain lawfully present non-pregnant adult non-citizens who are at risk of losing health coverage before they can be enrolled in a qualified health plan purchased through the Hawaii Health Insurance Exchange (called the "Hawaii Health Connector" or "the Connector") and to ensure access by certain aged, blind and disabled individuals to needed health care, including services that are not available through the Connector. These emergency rules became effective upon filing with the Lieutenant Governor's office on November 5, 2014 and are adopted for a period of not longer than 120 calendar days.

NO EFFECT ON CHILDREN UNDER AGE 19 YEARS AND PREGNANT WOMEN:

There is no effect on children under age 19 years and pregnant women who are not U.S. citizens and meet federal Medicaid requirements. These individuals are still eligible for Medicaid and their health care benefits will not change.

EFFECT ON INDIVIDUALS WHO ARE AGED, BLIND OR DISABLED:

Under the emergency rules, current beneficiaries who *are* aged, blind or disabled shall maintain their current benefits, pending adoption of administrative rules establishing the State-funded medical assistance program for certain lawfully present non-pregnant adult non-citizens who are aged, blind or disabled, which will provide benefits identical to benefits provided to aged, blind and disabled individuals under the federal Medicaid program.

The emergency rules also allow certain low-income lawfully present non-pregnant adult non-citizens who *are* aged, blind or disabled, to apply for State medical assistance that provides benefits identical to benefits provided to aged, blind and disabled individuals under the federal Medicaid program during an open application period beginning November 5, 2014 and continuing until the emergency rules expire.

EFFECT ON INDIVIDUALS WHO ARE NOT AGED, BLIND OR DISABLED:

Under the emergency rules, current beneficiaries who are *not* aged, blind or disabled shall maintain their current State medical assistance benefits for a period of not longer than 120 calendar days. During this time, DHS will send their information to the Connector, and the Connector will determine their eligibility for federal tax credits. In addition, DHS will pay the eligible individual's share of the health insurance premium to the qualified health plan in which the individual is enrolled beginning January 1, 2015, as long as the information needed to verify eligibility for this premium assistance is provided by the Connector to the individual's qualified health plan. This premium assistance benefit will be provided on an emergency basis until the DHS has adopted administrative rules establishing the new Premium Assistance Program.

A copy of the emergency rules will be available for public viewing, from Monday – Friday, exclusive of state holidays, between the hours of 9:00 a.m. to 2:00 p.m., at the appropriate Med-QUEST Division offices on the respective islands listed below. On Oahu, the emergency rules will be available at 601 Kamokila Boulevard, Room 518, Kapolei, Hawaii 96707, between the hours of 7:45 a.m. to 4:30 p.m., and 801 Dillingham Boulevard, 3rd Floor, Honolulu, Hawaii 96817, between the hours of 9:00 a.m. to 2:00 p.m., from Monday – Friday, exclusive of state holidays.
